Our Government is committed to ensuring that British Columbia is responsive to the needs of our apprentices, workers, employers, unions, and industry stakeholders, all those who are key to building a strong and sustainable economy. As part of this commitment, the Honourable John Horgan, Premier, has issued each of us mandate letters with direction to restore compulsory trades in British Columbia, and we are eager to begin this important work.

We would like to assure you and your members that comprehensive stakeholder engagement on the implementation of compulsory trades is a priority. Planning is currently underway to launch multiple engagement opportunities across the province. Workers, organized labour, businesses, Indigenous partners, members of the public, and others will be invited to participate. Our goal is to hear directly from a broad spectrum of workers and employers to ensure differing perspectives are taken into consideration. We value your experience and expertise and look forward to your members' participation in these upcoming virtual engagement sessions.

We would also like to stress our government's focus on B.C.'s COVID-19 economic recovery for businesses, communities, and families. We know B.C.'s recovery depends on limiting the spread of COVID-19 and an effective rollout of the vaccine, ensuring the safe operation of businesses, investing in our communities and building infrastructure, job creation and retraining programs to connect people to new job opportunities, and building upon our immediate relief measures by continuing to provide supports for people and businesses hardest hit. Our ministries will continue to encourage this recovery, which includes increasing pathways to apprenticeship completion for more workers, supporting accessible skills training and career development opportunities in the trades, and continuing to maintain and enhance current high standards of worker and public safety.

We look forward to working closely with you and your members to ensure our province has the skilled trades workforce we need to build critical infrastructure, realize the potential of a cleaner environment, and maintain the services that British Columbians rely on for now and into the future.
